GENERAL JOB DESCRIPTION:

My position with the Sea Grant Law and Policy Program involves a combination of academics; research; student training; public education, outreach and extension and public service. I teach "Coastal Zone Management" to upper level undergraduates and graduate students. The purpose of the course is to give my students some insight into the interaction between science and law and policy that can sometimes be convoluted and confusing. I feel that such knowledge is crucial both from the perspective of scientists and the legal profession and policy makers. My research projects are oriented towards legal issues affecting the wise use and conservation of coastal resources and have, over the years, involved very diverse topics. Many of these projects arise from actual issues and conflicts that have arisen in Louisiana and elsewhere.

I work regularly with individuals and groups interested in affecting legal and policy issues in the ocean and coastal areas in Louisiana and the Gulf region. Often this work involves analysis the legal regime surrounding the issue, discussions with the user groups and stakeholders to determine their needs and a determination whether legal and policy changes are necessary to bring about the desired result. In many cases I will find that the desired goal will be achievable under existing law and policy or that proposed changes of law or policy will not adversely affect the goal. In some cases I will determine that such changes are necessary to effect the goal. In those cases I often work with the stakeholder, the appropriate state agency and legislators to reach consensus and a solution, which may involve suggesting legislative changes and actually drafting proposed legislation. Two recent examples illustrate the process.

In 2003 the Louisiana Sea Grant oyster specialist was attempting to develop a pilot program that would test the efficacy of culturing hybrid oysters in a long line system in shallow coastal waters. This type of oyster farming had never before been attempted commercially in Louisiana though it has been successful in other parts of the world. The project was to be in conjunction with the Grand Isle Port Commission who wished to establish an aquaculture park for economic development purposes. The federal and state administrative agencies responsible for permitting the various aspects of the proposed project were to say the least somewhat adverse to the idea for a number of reasons ranging from perceived lack of authority to permit a new and unusual activity, to resource management concerns. Through a long series of negotiations with the applicants and the resource management agencies and in-depth research into the issues it was determined

that the project could probably be permitted under existing law with some creative interpretations and definitions but that legislative approval would be a better route. I worked with the Grand Isle Port Commission to draft legislation giving them authority to obtain the necessary permits and operate the project. The legislation was passed into law and the project is moving forward.

In 2004 I began work with the Department of Natural Resources Coastal Management Division, the Louisiana Department of Justice Attorney General's Office and the Louisiana Governor's Office to strengthen Louisiana's ability to require that federal activities on the Outer Continental Shelf be consistent with Louisiana's coastal zone management goals. The task involved researching, writing and publishing a paper on the state's legal position under the Coastal Zone Management Act's federal consistency provisions and educating the Governor's Office on the issue. Next, I worked with the Louisiana Legislature to draft an amendment to the State and Local Coastal Management Program to make clear the state's ability to impose its consistency authority with regard to OCS lease sales. That legislation was passed into law. When the state decided to assert its consistency power I assisted the Department of Natural Resources and the Attorney General's Office to prepare a legally defensible objection to the U.S. Department of Energy Minerals Management Service determination that their Outer Continental Shelf oil and gas leasing plans were consistent with Louisiana's coastal zone management program. When the dispute became intractable I was appointed Special Counsel to the Louisiana Attorney General's Office and their contracted legal counsel to assist in preparation of the state's law suit seeking a temporary restraining order against the Minerals Management Service to delay the next OCS lease sale until the state's concerns over environmental and social impacts had been addressed. That suit was filed and the United State's District Court judge ruled that while a temporary restraining order was not appropriate, the state was very likely to prevail on the merits and receive a permanent injunction against the lease sales at the trial date three months hence. In the meantime, through negotiations between the state and federal governments it was agreed that the next lease sale would be postponed until a proper assessment of the impacts could be preformed. This was the first time in history that an OCS lease sale was delayed by concerns over coastal impacts. Subsequently Congress enacted legislation giving the coastal states a larger share of OCS revenues with which to mitigate the impacts of oil and gas development in their ocean and coastal areas. Louisiana's action in challenging MMS' consistency determination demonstrated the state's commitment and determination to protecting its coastal resources and influenced Congress' attitude toward increased revenue sharing as a way to help the coastal states address the impacts.
